ORDER GRANTING PETITIONS FOR INTERVENTION;
GRANTING EX PARTE MOTION FOR EXTENSION
OF TIME TO FILE PETITION FOR INTERVENTION; GRANTING
PETITION FOR INTERVENTION; AND SETTING BRIEFING SCHEDULE

On June 28, 1989, the Hawaii State Teachers Association [hereinafter referred to as HSTA] filed a Petition for Intervention with the Board. Also, on June 28, 1989, the Hawaii Government Employees Association [hereinafter referred to as HGEA] filed a Petition for Intervention with the Board. After a review of the record and the petitions, the Board finds that the HSTA and the HGEA have alleged sufficient interests pertinent to the issues presented to be granted intervenor status. Pursuant to Administrative Rules § 12-42-8(g)(14), the HSTA and the HGEA's petitions for intervention are hereby granted.

On June 29, 1989, John Waihee, Governor of the State of Hawaii [hereinafter referred to as State] filed an Ex Parte

Motion for Extension of Time to File Petition for Intervention. In an affidavit attached to the motion, the State's representatives, Ruth Tsujimura and Sherri-Ann Loo, aver that the State failed to heed the deadline to file a Petition for Intervention due to miscommunication between the State's representatives and their predecessor on the instant case. For good cause shown and there being no resulting prejudice, the Board hereby grants the State an extension of time in which to file its petition for intervention.

Also on June 29, 1989, the State filed a Petition for Intervention with the Board. After a review of the record and the petition, the Board finds that the State has alleged a sufficient interest pertinent to the issues presented to be granted intervenor status. Pursuant to Administrative Rules § 12-42-8(g)(14), the State's Petition for Intervention is hereby granted.

The briefing schedule in the instant matter is set forth as follows:

The State's answering brief addressing issues set forth in Petitioner's Memorandum in Support of Petition for Declaratory Ruling Regarding Health Funds Contributions, attached to its Petition for Declaratory Ruling, is due July 17, 1989. Petitioner and intervenors HGEA and HSTA will file responsive briefs thereto by July 31, 1989.
