ORDER GRANTING UPW'S MOTION TO
RESCHEDULE PREHEARING CONFERENCE AND HEARING

On August 11, 1989, Complainant UNITED PUBLIC WORKERS, LOCAL 646, AFL-CIO, AFSCME [hereinafter referred to as UPW], by and through its counsel, Herbert R. Takahashi, Esq., filed a Motion to Reschedule Prehearing Conference and Hearing with this Board in Case No. CE-01-129.

In his supporting affidavit, Complainant's counsel stated that he will be unable to attend the prehearing conference scheduled for August 25, 1989, and the hearing presently scheduled for September 1, 1989, because of conflicts in his trial calendar.

On August 3, 1989, UPW's counsel filed motions to consolidate Case No. CU-01-62 and Case No. CE-01-129. This Board thereupon issued orders consolidating cases for disposition as requested in UPW's counsel's Motion. Accordingly, the prehearing conference in Case No. CU-01-62 scheduled for August 15, 1989 is cancelled. Likewise, the prehearing conference scheduled in Case No. CE-01-129 for August 25, 1989 and the hearing scheduled for September 1, 1989 are cancelled.

For good cause shown, the Board hereby grants Complainant's Motion to Reschedule Prehearing Conference and Hearing.

YOU ARE HEREBY NOTIFIED that the prehearing conference in Case Nos. CU-01-62 and CE-01-129 is rescheduled to October 6, 1989 at 9:00 a.m. in the Board's hearings room, Room 203, 550 Halekauwila Street, Honolulu, Hawaii.

YOU ARE ALSO NOTIFIED that the Board will conduct a hearing on Case Nos. CU-01-62 and CE-01-129 on October 20, 1989 at 10:00 a.m. at the Department of Liquor Control, Hilo Lagoon Centre, 101 Aupuni Street, Suite 230, Hilo, Hawaii. Pertinent provisions of the notices issued on July 21, 1989 and August 9, 1989, respectively, remain applicable.
