ORDER DENYING RESPONDENT UNITED PUBLIC WORKERS,  
AFSCME, LOCAL 646, AFL-CIO'S MOTION TO TAKE DEPOSITIONS  
UPON ORAL EXAMINATIONS AND FOR PRODUCTION OF DOCUMENTS

On October 16, 1989, Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW), by and through its counsel, Herbert R. Takahashi, Esq., filed a Motion to Take Depositions Upon Oral Examinations and for Production of Documents with this Board. In his supporting affidavit, counsel

requested leave of this Board to take the depositions of ROGER R. MARTIN, Suzanne Martin, Larry S. Tanimoto, Kenneth Loeffler, Jerry Martines, and Amy Hanagami and for production of documents.


On November 28, 1989, a prehearing conference in Case Nos. CU-01-62 and CE-01-129 was conducted by conference call. Mr. Takahashi was present in the Board's offices at that time. Complainant ROGER R. MARTIN and Mr. Gerald Takase, Deputy Corporation Counsel, were contacted at their respective phone numbers.

At the prehearing conference, the respective parties agreed to voluntarily produce the relevant personnel and medical records which are the subject matter of these cases. Moreover, after a thorough discussion of the relevant issues, there does not appear to be good cause to conduct discovery at this time.

Accordingly, based upon the foregoing, the Board hereby denies Respondent UPW's Motion to Take Depositions Upon Oral Examinations and for Production of Documents.
