## ORDER GRANTING UPW AND COMPLAINANT'S MOTIONS FOR EXTENTIONS OF TIME TO FILE MEMORANDUMS

On May 2, 1990, Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW), by and through its counsel, Herbert R. Takahashi, Esq., filed with this Board a Motion for Extension of Time to File Memorandum, together with a supporting affidavit. UPW moves this Board for an extension of three weeks to file its memorandum of fact and law. orde

In the affidavit, Mr. Takahashi stated he was retained within the last two weeks to pursue several civil matters requiring preparation for filing motions for temporary restraining orders, preliminary injunctions, and other related actions. Because of the unexpected nature of these cases and the need to travel to the neighbor islands, UPW's counsel was unable to submit the memorandum on May 2, 1990. Counsel also stated that Deputy Attorney General Colette Gomoto has no objections to this motion. Further, counsel attempted to contact Complainant Lepere at his residence to no avail.

On May 3, 1990, Complainant LEPERE, filed with this Board a Motion for Extension of Time to File Memorandum, together with a supporting affidavit. Complainant moves this Board for an extension of three weeks to file his memorandum of fact and law.

In the affidavit, Mr. LEPERE stated he was unable to prepare the subject memorandum as scheduled because of time constraints involving his preparation to file a civil complaint in the Circuit Court of the First Circuit. Further, Complainant stated that he needs more time to review the hearing transcript in order to submit his memorandum.

For good cause shown, the Board hereby grants UPW and Complainant's motions. Respondent UPW and Complainant LEPERE are directed to file their Memorandums on or before May 23, 1990.
