ORDER DENYING RESPONDENTS' APPLICATION FOR TAKING DEPOSITIONS UPON ORAL EXAMINATION AND FOR ISSUANCE OF SUBPOENAS AND SUBPOENA DUCES TECUM

On December 11, 1990, Respondents FRANK F. FASI,
Mayor of the City and County of Honolulu and the DEPARTMENT OF
HEALTH, City and County of Honolulu, filed an Application for
Taking Depositions Upon Oral Examination and for Issuance of
Subpoenas and Subpoena Duces Tecum. By the Application,
Respondents requested leave of this Board to take the depositions of Tommy Palmeira, Patricia Kelford and Belinda Lee, and
to require Belinda Lee to bring with her any and all documents
described in Respondents' subpoena. The affidavit of counsel
for Respondents states that he believes that the above-named
individuals have information which is relevant, or, if not

relevant, information which will establish certain facts concerning the allegations made in this case.

On December 18, 1990, Complainant UNITED PUBLIC
WORKERS, AFSCME, LOCAL 646, AFL-CIO, by its representative,
filed a Memorandum in Opposition to Respondents' Application
for Taking Depositions Upon Oral Examination and for Issuance
of Subpoenas and Subpoena Duces Tecum. Complainant argues that
Respondents have failed to show good cause why the subject
application should be granted. Complainant also argues that
the granting of such application would unduly prolong the
proceedings scheduled for January 10, 1991. Further, Complainant argues that Respondents have not shown good cause why the
documents described in Respondents' subpoena are needed.

On December 31, 1990, Respondents filed a Response to Complainant's memorandum.

After reviewing the written submissions by the parties and upon consideration of the written arguments presented, the Board hereby denies Respondents' Application to Take Depositions Upon Oral Examination and for Issuance of Subpoenas and Subpoena Duces Tecum because Respondents have failed to establish good cause to grant its Application. Further, the Board believes that such discovery, if granted, would unduly delay and prolong the proceedings.
