IWAI (IWAI) requested a one month continuance of the hearing in this matter to permit him to find an attorney to represent him. Respondent HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME LOCAL 152, AFL-CIO (HGEA), by and through its counsel, Dennis W.S. Chang, Esq., had no objection to the continuance of the hearing date. On April 30, 1992, Complainant IWAI filed a request for a continuance of the hearing originally scheduled for May 1, 1992 until June 1, 1992.

For good cause shown, the hearing in this matter is continued until June 1, 1992 at 10:00 a.m. in the County Council Chambers, 4396 Rice Street, second floor, in Lihue, Kauai. The hearing may continue from day to day until completed.

On May 7, 1992, counsel for HGEA filed a letter requesting a second prehearing conference to determine if IWAI has found a representative and to determine the witnesses to be called.

YOU ARE HEREBY NOTIFIED that the Board will conduct a second prehearing conference on the above-entitled prohibited practice complaint on May 26, 1992 at 9:00 a.m. by conference call. Again, the parties or their representatives will be contacted at their respective telephone numbers unless Complainant informs the Board of his representative's telephone number. Complainant IWAI is directed to file a Prehearing Statement two days prior to the prehearing conference. In addition, Respondent HGEA is directed to file its motion to dismiss, if any, with the Board prior to the prehearing conference.

Appropriate provisions of the notice issued on April 3, 1992, remain applicable.
