ORDER GRANTING RESPONDENTS' MOTION FOR EXTENSION
OF TIME TO FILE A MEMORANDUM IN OPPOSITION TO
COMPLAINANT HGEA/AFSCME'S MOTION FOR SUMMARY JUDGMENT

On May 29, 1992, Respondents BOARD OF REGENTS, University of Hawaii and JOHN WAIHEE, Governor, State of Hawaii, Respondents, by and through their attorneys, Warren Price III, Attorney General, and Elton K. Suzuki, Deputy Attorney General, filed a motion for extension of time within which to file a memorandum in response to Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO, (HGEA)'s motion for summary judgment filed on May 26, 1992. Respondents requested an extension of time up to and including June 19, 1992 to file their memorandum.


In a supporting affidavit attached thereto, Elton Suzuki stated that due to his caseload and additional responsibilities, he needs additional time to conduct the necessary legal research to

respond to HGEA's motion. Counsel also states that Complainant's attorney, Charles K.Y. Khim, Esq., has no objection to the request.


Respondents' motion is hereby granted. Their memorandum in opposition to HGEA's motion for summary judgment shall be filed by June 19, 1992.
