ORDER GRANTING WITHDRAWAL OF PROHIBITED
PRACTICE COMPLAINT AGAINST RESPONDENTS
WIL MURAKAMI, PATRICIA BERGIN, AND
DEPARTMENT OF EDUCATION; AND NOTICE OF HEARING

During the prehearing conference held by conference call on October 8, 1992, Complainant GAYLE M. SUZUKI (SUZUKI) stated her desire to withdraw her prohibited practice complaint against WIL MURAKAMI, PATRICIA BERGIN and the DEPARTMENT OF EDUCATION (collectively EMPLOYER) in Case No. CE-05-169. SUZUKI indicated that she intended to pursue the filing of contractual grievances with the EMPLOYER.


For good cause shown, the Board grants Complainant's request pursuant to § 12-42-44, Administrative Rules.

YOU ARE HEREBY NOTIFIED that the Board will conduct a hearing, pursuant to §§ 89-5(b)(4) and 89-14, Hawaii Revised Statutes, on the harassment complaint against CELESTE KUMULAE and the HAWAII STATE TEACHERS ASSOCIATION in Case No. CU-05-84 on November 13, 1992 at 10:00 a.m. in the Tax Office Conference Room, Hilo State Office Building, 75 Aupuni Street, Hilo, Hawaii. The purpose of the hearing is to receive evidence and arguments on whether Respondents committed the prohibited practices as alleged by Complainant. The hearing may continue from day-to-day until completed. The parties shall submit four copies of any exhibits identified and introduced into the record to the Board. Additional copies for opposing counsel shall be provided.


All parties have the right to appear in person and to be represented by counsel or other representative.
