IT IS HEREBY STIPULATED AND AGREED, by and between Complainant, HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME Local 152, AFL-CIO ("COMPLAINANT"), by and through its attorney, DEBRA A. KAGAWA, ESQ. and Respondents, KIRK CALDWELL, Mayor, City and County of Honolulu, ERNEST Y.W. LAU, P.E., Manager and Chief Engineer of the Board of Water Supply, ELLEN KITAMURA, Deputy Manager and Chief Engineer, Board of Water Supply, MICHELE THOMAS, Human Resources Manager, Board of Water Supply, CAROLEE C. KUBO, Director of Human Resources City and County of Honolulu, NOEL T. ONO, Assistant Director of Human Resources (collectively "RESPONDENTS"), by and through their attorney, LESLIE P. CHINN, ESQ., Deputy Corporation Counsel, that the 40-day requirement in Haw. Rev. Stat. § 377-9(b) is hereby waived.

COMPLAINANT and RESPONDENTS further stipulate and agree to the following:

- 1. The deadline for RESPONDENTS to file the Answer to the Prohibited Practice Complaint, filed on November 17, 2017, is continued to December 1, 2017;
- 2. The Prehearing Conference currently scheduled on December 6, 2017 at 9:00 a.m. is continued to December 15, 2017 at 1:30 p.m.; and
- 3. The hearing on the Prohibited Practice Complaint, filed on November 17, 2017, and all other prehearing deadlines are continued until such time the Hawaii Labor Relations Board schedules a new hearing date and deadlines at the Prehearing Conference.

Both parties reserve the right to move to reschedule the hearing on the Prohibited Practice Complaint, filed on November 17, 2017, and reset all prehearing deadlines.
