On October 5, 1993, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA), by and through its counsel, filed a Motion to Extend the Time Within Which to File a Response to Respondents BOR and Waihee's Motion to Dismiss with Prejudice which was due on October 5, 1993. HGEA requests a two-week extension until October 19, 1993. The affidavit of counsel filed in support of the motion indicates that additional time is needed to prepare his brief because of pending commitments and that opposing counsel has no objections to the motion.

For good cause shown, Complainant's motion is hereby granted.






