By Pretrial Order issued November 12, 2015, the Hawaii Labor Relations Board (Board) set a deadline of November 30, 2015 for Complainant DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS (Complainant) to file a response to Respondent COLOR DYNAMICS, INC.'S (Respondent) Motion for Reconsideration of Board Order No. 711 denying Respondent's Partial Motion for Summary Judgment, filed November 9, 2015.

On November 24, 2015, Complainant filed at the Board Complainant's Motion to Suspend Deadline to File Response/Opposition to Respondent Color Dynamics, Inc.'s November 9, 2015 Motion for Reconsideration of Order No. 711 Denying Respondent's Partial Motion for Summary Judgment Filed on October 28, 2015. In his declaration attached to the November 24, 2014 Motion, Complainant's counsel stated that counsel for the parties had mutually agreed to suspend the Board's November 30, 2015, deadline for Complainant to respond to Respondent's October 28, 2015 Motion in order to give the parties time to continue to explore settlement discussions.

On November 24, 2015 also, Respondent COLOR DYNAMICS, INC. (Respondent) filed at the Board Respondent's Statement of No Opposition to Complainant's November 24, 2015 Motion.

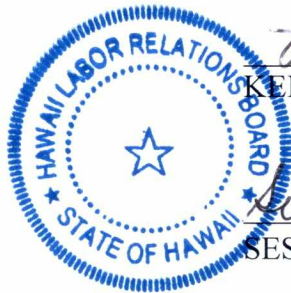
