RELATIONS' MOTION TO MOVE INITIAL CONFERENCE/SETTLEMENT
CONFERENCE; NOTICE OF RESCHEDULED INITIAL/ SETTLEMENT CONFERENCE

On November 30, 2015, Complainant DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS (Complainant) filed Complainant's Motion to Move Initial Conference/Settlement Conference (Motion) at the Hawaii Labor Relations Board (Board), requesting that the Initial Conference/Settlement Conference (IC/SC) scheduled on December 2, 2015 be rescheduled on the morning of January 20 or 21, 2016 to give the parties time to review the file in this matter and to explore possible settlement. In his declaration attached to the Motion, Complainant's counsel stated that Respondent STERLING PACIFIC CONSTRUCTION, LLC (Respondent), through its representative, Miro Nesovik, owner of Respondent, agreed to move the IC/SC to January 20 or 21, 2016, and would be calling the Board to convey his agreement.

To date, Respondent has not contacted the Board and has not expressed to the Board any opposition to Complainant's request to reschedule the IC/SC.

Consequently, for good cause shown by Complainant, the Board GRANTS Complainant's November 30, 2015 Motion and reschedules the IC/SC in this matter as indicated below.
