STIPULATION TO CONTINUE TRIAL DATE

WHEREAS, pursuant to the Director's motion to continue the trial date filed on November 30, 2015, the Labor Board issued the Order Granting Director's Motion to Continue Discovery Cutoff and Trial; Amended Pretrial Order, Order No. 633, dated December 17, 2015,

which, inter alia, continued the trial date to March 22, 2016;

WHEREAS, counsel for the Director has a family matter to attend to during the week of the trial in Canada, and therefore, will be out of the country during that time period. Counsel for the Director spoke to Kelly Dung who, on behalf of the Respondent, PIONEER MARBLE & GRANITE, LLC, is agreeable to stipulating to continue the trial date to some date in April 2016.


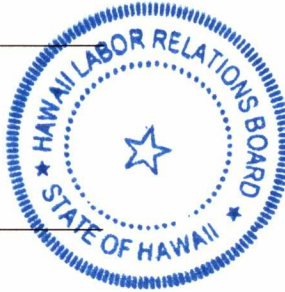


