SECOND AMENDED PRETRIAL ORDER

By Order No. 696, Pretrial Order dated October 2, 2015, the Hawaii Labor Relations Board (Board) set the trial in the above-captioned matter for January 6, 2016 at 9:00 a.m. Pursuant to the motion filed by Complainant, DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS (Director), the Board issued Order No. 733, dated December 17, 2015, whereby trial was continued to March 22, 2016 at 9:00 a.m.

By Stipulation to Continue Trial Date and Order, Order No. 747, Complainant and Respondent PIONEER MARBLE & Granite, LLC. (Respondent) agreed and stipulated, and the Board approved and ordered, that trial in this case be reset for an April 2016 date to be determined by the Board. Accordingly, the Board issues this Second Amended Pretrial Order as follows:
