2016, reset the following pertinent deadlines:


Discovery Cutoff Date: February 9, 2016


This stipulation is not submitted for the purpose of delay.

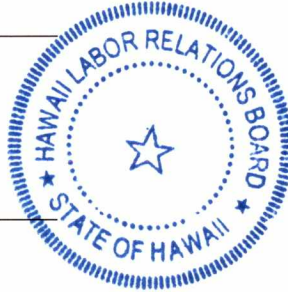
