exchange of information for the purpose of resolving the case;


WHEREAS, further time to conduct and evaluate discovery is required by both

parties, and hence, agree to a continuation of the status letter due date;


THEREFORE, IT IS HEREBY STIPULATED by and between the DIRECTOR,
