SECOND STIPULATION TO EXTEND TIME FOR FILING OF STATUS LETTER

Director, Department of Labor and Industrial Relations ("DLIR"), Complainant, and the The Gas Company, LLC dba Hawaii Gas ("HG"), Respondent, again agreed to extend the due date for the status letter from the previously extended deadline of May 26, 2016 to a new deadline of on or before June 27, 2016, for the following reasons.

The parties and their legal counsel met on March 21, 2016, to present their respective positions and discuss a possible settlement relating to the citation. On March 28, 2016, DLIR through its counsel presented a proposal of settlement to HG for its consideration. On April 26, 2016, HG responded to the settlement proposal extended by DLIR. Thereafter, the parties have had discussions regarding the possible terms of the settlement. At the present time, the parties

have reached a tentative settlement and counsel for DLIR is preparing a draft of the settlement agreement. However, the parties do not believe the agreement will be finalized by the May 26, 2016 deadline for the parties to file the status letter with the Hawaii Labor Relations Board ("HLRB").

In view of the current drafting of the agreement on the tentative settlement terms between DLIR and HG, the parties request a continuance of the current deadline to on or before June 27, 2016 to file their status letters if they are unable to finalize the agreement.

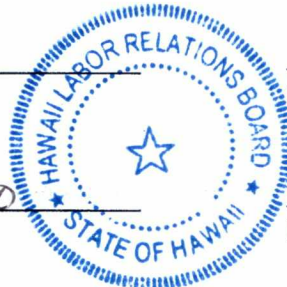
