STIPULATION TO CONTINUE TRIAL
AND DISCOVERY CUTOFF DATES

WHEREAS, at the pre-trial conference held on June 21, 2016, the Hawaii Labor Relations Board ("Labor Board"), set the discovery cut-off in this case for July 15, 2016, and trial for July 29, 2016, at 9:00 a.m.;

WHEREAS, the Director's HIOSH inspector currently lives in Washington State and is unable to return to Honolulu to testify, and hence, the Director desires to conduct a

deposition of the witness to preserve his testimony for trial. After conferring with counsel for Respondent, the parties are agreeable to continue the discovery cutoff and the trial date set by the Labor Board.

THEREFORE, IT IS HEREBY STIPULATED by and between the DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS and HI-POWER SOLAR, LLC, by and through their respective representatives, to extend the discovery cutoff and trial dates. The parties are agreeable to having the Labor Board re-set the discovery cutoff date to August 26, 2016, and continue the trial date to September 9, 2016, at 9:00 a.m.

This stipulation is not submitted for the purpose of delay.


