ORDER APPOINTING AN ARBITRATOR

By letter dated January 28, 2019, Exclusive Representative HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA) and Ryker Wada, Chief Negotiator in the Office of Collective Bargaining in the Executive Office of the Governor, representing the Employer group, jointly sent a letter to the Hawai'i Labor Relations Board (Board) notifying the Board that they agreed to the selection of KATHRYN T.
