**ORDER GRANTING COMPLAINANT'S EX PARTE MOTION
TO ADVANCE MOTION TO SET ASIDE ORDER NUMBERS 3455 AND 3455A**

On June 8, 2018, Complainant JOSEPH H. CAMPOS II, Ph.D., self-represented litigant (SRL) (Complainant or Dr. Campos) filed a Prohibited Practice Complaint (Complaint) with the Hawai'i Labor Relations Board (Board), alleging violations of Hawai'i Revised Statutes (HRS) §§ 89-13(a)(1), (4), (7), and (8) by Respondents UNIVERSITY OF HAWAI'I AT MĀNOA (UH) and UNIVERSITY OF HAWAI'I PROFESSIONAL ASSEMBLY (UHPA) (collectively, Respondents).

On April 24, 2019, the Hawai'i Labor Relations Board (Board) issued Order No. 3455A, Amended Order Granting, in Part, and Denying, in Part, Respondent University of Hawai'i's Motion to Dismiss Prohibited Practice Complaint; and Granting, in Part, and Denying, in Part, Respondent University of Hawai'i Professional Assembly's Motion to Dismiss, or in the Alternative for Summary Judgment. In Order No. 3455A, among other things, the Board dismissed the alleged HRS § 89-13(a)(7) and (8) claims, as well as the claim of the breach of the duty of fair representation. Accordingly, the Board dismissed UHPA from any further proceedings in the case and closed Case No. 18-CU-07-362.

On October 11, 2019, Dr. Campos filed a Motion to Set Aside Order Numbers 3455 and 3455A (Motion to Set Aside), as well as an Ex Parte Motion to Advance Motion to Set Aside Order Numbers 3455 and 3455A (Motion to Advance).

On October 14, 2019, UHPA filed University of Hawaii Professional Assembly's Opposition to Complainant's Motion to Set Aside Order Numbers 3455 and 3455A and University of Hawaii Professional Assembly's Opposition to Complainant's Ex Parte Motion to Advance Motion to Order Numbers 3455 and 3455A (collectively, UHPA's Oppositions).

On October 15, 2019, UH filed Respondent University of Hawai'i's Opposition to Complainant's Motion to Set Aside Order Numbers 3455 and 3455A and Respondent University of Hawai'i's Opposition to Complainant's *Ex Parte* Motion to Advance Motion to Set Aside Order Numbers 3455 and 3455A (collectively, UH's Oppositions). UH also joined in UHPA's Oppositions.

The Board hereby grants Dr. Campos' Motion to Advance and schedules a hearing on the Motion to Set Aside as follows below.

As UHPA is no longer a party to this case, **UHPA is not required to attend the Motion Hearing.**
