#### MINUTE ORDER

On April 21, 2020, the Hawai'i Labor Relations Board (Board) held a prehearing conference in the above-listed consolidated cases. At the prehearing conference, among other things, the Board took the following actions:

1. Granted the Withdrawal of Case No. 20-CU-381, GORDON LESLIE; BERNARD KUAMOO; GEORGE SHERIDAN; DEANGELO DIXON; and FELICIANO SAMSON v. UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO;
2. Ordered the Complainants GORDON LESLIE; BERNARD KUAMOO; GEORGE SHERIDAN; DEANGELO DIXON; WYATT LEE; and FELICIANO SAMSON (Complainants) in these consolidated cases to file an Amended Prohibited Practice Complaint on or by **June 1, 2020**. This Amended Prohibited Practice Complaint must include:
  - a. A statement from each individual Complainant that they wish to participate in this case and that they give their permission to Lieutenant Gordon Leslie to serve as their representative, attached as an exhibit(s) to the Amended Complaint. The Board will allow the Complainants to add additional complainants as necessary.
  - b. The inclusion of alleged violations of Hawai'i Revised Statutes (HRS) § 89-13(a)(7) and (b)(4), to the extent that the Complaints allege violations of any section of HRS Chapter 89 other than violations of HRS § 89-13.

The Amended Prohibited Practice Complaint may **not** include any references to a “class action” suit.

- c. A copy of the Class Grievance JM-11-15, filed on July 11, 2011, attached as an exhibit to the Amended Complaint.
3. Ordered the Respondents DAVID Y. IGE, Governor, State of Hawai‘i; NOLAN P. ESPINDA, Director, Department of Public Safety, State of Hawai‘i; SCOTT HARRINGTON, Warden, Halawa Correctional Facility; LYLE ANTONIO, Deputy Warden, Halawa Correctional Facility; CALVIN MOCK, Chief of Security, Halawa Correctional Facility; JANE AND JOHN DOE 1-25, State of Hawai‘i, Department of Public Safety, and UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO in this case to file an Answer to the Amended Prohibited Practice Complaint on or by **June 11, 2020** or ten days after service of the Amended Prohibited Practice Complaint, whichever is sooner.
