On December 31, 2020, the Hawai'i Labor Relations Board (Board) issued a Notice of Complainant's Motion to Continue Hearing Set for January 28, 2021 (Notice). The Notice informed the parties that the Board received a letter from Complainant's counsel on December 23, 2020 requesting a continuance for the Motion Hearing set for January 28, 2021 and to reschedule the Motion Hearing to a date beyond February 2, 2021 (Hong's Letter). Hong's Letter was included with the Notice. The Notice further informed the parties that the Board deemed the letter as a motion and any objections should be filed within five (5) business days of receipt.
