ORDER DISMISSING THE CASE WITHOUT PREJUDICE AND CLOSING THE CASE

On November 8, 2010, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (Complainant) filed a prohibited practice complaint (Complaint) with the Hawai'i Labor Relations Board (Board) against Respondents KEITH VIERA, Chairperson, Ho'okāko'o Corporation; GLEN KILA, CEEO, Kamaile Academy Public Charter School; KATHRYN MATAYOSHI, Superintendent, Department of Education, State of Hawai'i; GARRETT TOGUCHI, Chairperson, Board of Education, Department of Education, State of Hawai'i; BOARD OF EDUCATION, Department of Education, State of Hawai'i; LINDA LINGLE, Governor, State of Hawai'i; MARIE LADERTA, Chief Negotiator, Office of Collective Bargaining and Director of Department of Human Resources Development, State of Hawai'i; and KIRT INGRAM, President, Sodexo America, LLC (Respondents and collectively with Complainant as Parties).

On January 12, 2021, the Complainant filed with the Board its Stipulation to Withdraw Complainant's Prohibited Practice Complaint Without Prejudice (Stipulation) signed by all parties through their respective counsels.

Accordingly, based on the Stipulation, the Board dismisses the case without prejudice. This case is closed.
