On November 8, 2010, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (Complainant) filed a prohibited practice complaint (Complaint) with the Hawai'i Labor Relations Board (Board) against Respondents KEITH VIERA, Chairperson, Hoʻokākoʻo Corporation; GLEN KILA, CEEO, Kamaile Academy Public Charter School; KATHRYN MATAYOSHI, Superintendent, Department of Education, State of Hawaiʻi; GARRETT TOGUCHI, Chairperson, Board of Education, Department of Education, State of Hawaiʻi; BOARD OF EDUCATION, Department of Education, State of Hawaiʻi; LINDA LINGLE, Governor, State of Hawaiʻi; MARIE LADERTA, Chief Negotiator, Office of Collective Bargaining and Director of Department of Human Resources Development, State of Hawaiʻi; and KIRT INGRAM, President, Sodexo America, LLC (Respondents and collectively with Complainant as Parties).
