ORDER APPOINTING AN ARBITRATOR

By letter dated January 28, 2019, Exclusive Representative HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA) and Ryker Wada, Chief Negotiator in the Office of Collective Bargaining in the Executive Office of the Governor, representing the Employer group, jointly sent a letter to the Hawai'i Labor Relations Board (Board) notifying the Board that they agreed to the selection of LAWRENCE E. LITTLE as the neutral chair of the three-member arbitration panel for the resolution of the impasse in the bargaining unit 09 negotiations, affecting registered professional nurses.

Accordingly, the Board hereby appoints LAWRENCE E. LITTLE as the neutral arbitrator and chairperson of the arbitration panel, and he shall have such authority and duties as conferred by law.

The parties are ordered to provide the names of the remaining two members of the arbitration panel, to be selected by the parties in accordance with Hawai‘i Revised Statutes (HRS) § 89-11(e)(2)(A), within five working days of the date of this order.
