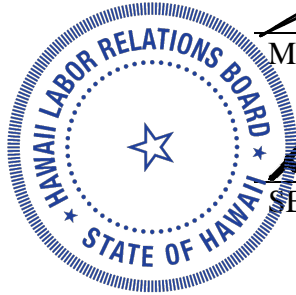
ORDER DISMISSING THE CASE WITH PREJUDICE

On January 31, 2019, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO and Respondents KIRK CALDWELL, MAYOR, CITY AND COUNTY OF HONOLULU; ERNEST Y.W. LAU, P.E., MANAGER AND CHIEF ENGINEER OF THE BOARD OF WATER SUPPLY; ELLEN KITAMURA, DEPUTY MANAGER AND CHIEF ENGINEER OF THE BOARD OF WATER SUPPLY; CAROLEE KUBO, DIRECTOR, DEPARTMENT OF HUMAN RESOURCES, CITY AND COUNTY OF HONOLULU; AND NOEL ONO, ASSISTANT DIRECTOR, DEPARTMENT OF HUMAN RESOURCES, CITY AND COUNTY OF HONOLULU (collectively Parties) filed a Stipulation for Dismissal with Prejudice as to All Claims and All Parties (Stipulation) with the Hawai'i Labor Relations Board (Board).
