ORDER APPOINTING NEUTRAL ARBITRATOR AND CHAIRPERSON

By letter, dated February 4, 2019, Exclusive Representative HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO and Ryker Wada, Chief Negotiator, Office of Collective Bargaining, State of Hawai‘i, representing the Employer group (State of Hawai‘i, the City and County of Honolulu, and the counties of Hawai‘i, Maui, and Kaua‘i) jointly notified the Hawai‘i Labor Relations Board (Board) that they agreed to the selection of KATHRYN T. WHALEN as the neutral Chair for the three-member interest arbitration panel for the resolution of the impasse in the bargaining unit 14 negotiations, affecting State law enforcement officers and state and county ocean safety and water safety officers.

Accordingly, the Board hereby appoints KATHRYN T. WHALEN as the neutral arbitrator and chairperson of the arbitration panel, and she shall have such authority and duties as conferred by law.

The Board will certify the remaining members of the panel and confer such authority and duties upon the panel upon submission by the parties of their selections for the other two members of the arbitration panel in accordance with Hawai‘i Revised Statutes § 89-11(e)(2)(A).

ⁱ The Hawai'i Labor Relations Board has applied the Hawai'i Rules of Civil Procedure (HRCPP) where its administrative rules are silent. Dep't of Safety, State of Hawaii v. United Public Workers, AFSCME, Local 646, AFL-CIO, Board Case No, CU-10-322, Order No. 2944 at *2 n. 2 (2013). HRCPP Rule 25(d)(1) provides that when a public officer is a party to an action in an official capacity and, while that action is pending, the public officer dies, resigns, or otherwise ceases to hold office, the officer's successor is automatically substituted as a party. Proceedings following the substitution shall be in the name of the substituted party, but any misnomer that does not affect the substantial rights of the parties will be disregarded.
