On March 13, 2019, the Hawai‘i Labor Relations Board (Board) issued a Notice, which among other things, scheduled hearings on the merits (HOM) on May 7, 8, and 9, 2019 from 9:00 a.m. to 4:00 p.m. in the HLRB Hearing Room, 830 Punchbowl Street, Rm. 434, Honolulu, Hawaii; and on July 1, 2019 from 9:30 a.m. to 4:00 p.m., July 2, 2019 from 9:00 a.m. to 4:00 p.m., and July 3, 2019 from 9:00 a.m. to 4:00 p.m. at the Aging and Disability Resource Center, Training Room, 1055 Kinoole Street, Hilo, Hawaii.

At the May 9, 2019 HOM, the testimony of Dayton Nakanelua (Nakanelua) was not completed. UPW’s counsel agreed that Nakanelua would return to testify on July 1, 2019. Accordingly, the Board orally informed the parties before the conclusion of the May 9, 2019 HOM that the venue for the July 1, 2, and 3, 2019 HOMs be changed from Hilo, Hawai‘i to the HLRB Hearings Room in Honolulu, Hawai‘i to continue with Nakanelua’s testimony and that the HOMs for those dates and location be re-noticed.

ORDER

The Board hereby orders that the venue for the July 1, 2, and 3, 2019 HOMs be changed from Hilo, Hawai‘i to the Board’s Hearings Room in Honolulu, Hawai‘i.


