The Hawai'i Labor Relations Board (Board) HEREBY ORDERS that:

- 1. Respondent DEPARTMENT OF PUBLIC SAFETY, State of Hawai'i (PSD), produce J. Marte Martinez (Ms. Martinez) as a witness at a hearing on the merits (HOM) noticed below for the purpose of answering questions from the Board regarding her qualifications as presented in her January 8-9, 2019 testimony; and
- 2. Ms. Martinez bring to the HOM noticed below **certified copies** of any and all records regarding her qualifications as presented through her January 8-9, 2019 testimony, including but not limited to transcripts, diplomas, certificates, and degrees pertaining to her graduation from Southern Oregon State College in criminal justice (criminology); any certifications by the Federal Law Enforcement Training Center (including but not limited to as a use of force

master instructor and force science); any certifications through the State of Oregon Department of Public Safety (including but not limited to as a master instructor); and any recertifications by the Departments of Public Safety in Mexico, Texas, Hawai'i, and the Department of Defense Federal Law Enforcement Training Center;

- 3. Respondent UNITED PUBLIC WORKERS, AFSCME LOCAL 646, AFL-CIO produce Dayton Nakanelua (Mr. Nakanelua) at the HOM noticed below to appear and testify regarding his knowledge, if any, of Ms. Martinez's qualifications as presented in her January 8-9, 2019 testimony, including but not limited to the date on which he became aware of those qualifications and/or lack thereof; and
- 4. Mr. Nakanelua bring to the HOM noticed below any communications or other documents, including but not limited to letters, emails, and notes, pertaining to Ms. Martinez's qualifications or lack thereof as presented in her January 8-9, 2019 testimony.

Should any party require visual or audio equipment to present any exhibit, that party shall be responsible for assuring that equipment is available and functioning during the HOM scheduled above.

The Board may schedule and notice additional further HOM in Hilo, Hawai'i and/or Honolulu, Hawai'i, to take additional rebuttal witnesses shown to be necessary.
