ORDER GRANTING, IN PART, COMPLAINANT ILWU LOCAL 142'S MOTION TO RESCHEDULE PREHEARING CONFERENCE, PRETRIAL CONFERENCE AND HEARING ON DISPOSITIVE MOTIONS, AND HEARING ON THE MERITS

On August 30, 2019, Complainant INTERNATIONAL LONGSHORE AND WAREHOUSE UNION ("ILWU"), LOCAL 142 (ILWU) filed the instant unfair labor practice complaint (Complaint) with the Hawai'i Labor Relations Board (Board).

On September 3, 2019, the Board issued Order No. 3555, Pretrial Order and Notices, which, among other things, informed Respondent HAWAIIAN MACADAMIA NUT SERVICES, LLC (KĀ'U DIVISION) (Respondent or Hawaiian Mac Nut) of the filing of the Complaint and scheduled certain hearing dates and deadlines.

On September 4, 2019, ILWU filed Complainant ILWU Local 142's Motion to Reschedule Prehearing Conference, Pretrial Conference and Hearing on Dispositive Motions, and Hearing on the Merits (Motion to Reschedule), stating, among other things, that ILWU's counsel, Lowell K.Y. Chun-Hoon (Chun-Hoon) has scheduling conflicts with certain dates set forth in Order No. 3555. ILWU also agreed to waive the 40-day requirements of Hawai'i Administrative Rules (HAR) §

12-41-7, mandating that the HOM "be held no less than ten nor more than forty days after the filing of the complaint or amendment thereof..." if necessary for rescheduling purposes.

On September 16, 2019, Hawaiian Mac Nut filed Hawaiian Macadamia Nut Services, LLC's *Joinder* in Complainant ILWU Local 142's Motion to Reschedule Prehearing Conference, Pretrial Conference, Hearing on Dispositive Motions, and Hearing on the Merits Filed 9/04/19 (Hawaiian Mac Nut Joinder), also asking to continue certain dates set forth in Order No. 3555. That same day, Hawaiian Mac Nut filed the Declaration of Paul M. Saito in Support of Hawaiian Macadamia Nut Services, LLC's *Joinder* in Complainant ILWU Local 142's Motion to Reschedule Prehearing Conference, Pretrial Conference, Hearing on Dispositive Motions, and Hearing on the Merits Filed 9/04/19 (Saito Declaration). In the Saito Declaration, Hawaiian Mac Nut also agreed to waive the 40-day requirements of HAR § 12-41-7.

ORDER

Accordingly, the Board GRANTS, in part, ILWU's Motion to Reschedule and will reschedule the Prehearing Conference scheduled for September 19, 2019 at 9:00 a.m. in Order No. 3555. The Board further suspends all other dates and deadlines set forth in Order No. 3555.
