On November 4, 2011 Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA), filed a prohibited practice complaint (Complaint) with the Hawaii Labor Relations Board (HLRB) against Respondents NEIL ABERCROMBIE, Governor, State of Hawaii; WILLIAM J. AILA, Chairperson, Board of Land & Natural Resources, State of Hawaii; and RANDY L. AWO, Acting Chief of Enforcement, Department of Land & Natural Resources, State of Hawaii (collectively, Respondents).

On March 1, 2021, HGEA filed its Motion to Withdraw Prohibited Practice Complaint Filed November 4, 2011 (Motion to Withdraw).

On March 1, 2021, Respondents filed Respondents' Statement of No Opposition to HGEA/AFSCME's Motion to Withdraw Prohibited Practice Complaint, Filed November 4, 2011.

Accordingly, the Board grants the Complainant's Motion to Withdraw. This case is closed.
