ORDER GRANTING WITHDRAWAL OF CASE

On December 5, 2019, Complainant LEE T. CHOW (Complainant) filed a prohibited practice complaint (Complaint) alleging that Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW) and Respondent DIRECTOR, DEPARTMENT OF ENVIRONMENTAL SERVICES, City and County of Honolulu (City, and with UPW, Respondents) committed prohibited practices.

The Hawai'i Labor Relations Board (Board) began the hearing on the merits (HOM) on January 13, 2020. On March 12, 2020, Complainant informed the Board that the UPW intended to take the underlying grievance to arbitration.

On December 26, 2020, Complainant informed the Board that the arbitrator had issued a decision in the underlying grievance arbitration.

The Board held a status conference on March 16, 2021, where the Board explained to Complainant that it could not modify the arbitration decision. Based on that knowledge, Complainant requested to withdraw the case, the Respondents had no objections, and the Board granted that request.

The Complaint is withdrawn, and this case is closed.
