The Notice stated that the case would be dismissed "unless a written objection is received from any party within ten days issuance of this notice, setting forth good cause as to why the case should not be dismissed."

Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA) submitted a statement of no objection to the dismissal.

In the ten-day period, the Board received no written notification from Respondents regarding the Notice of Intent to Dismiss. Based on HGEA's statement and Respondents' lack of response, the Board dismiss the case. This case is closed.
