**ORDER GRANTING COMPLAINANT'S MOTION TO EXTEND
DEADLINE FOR DISPOSITIVE MOTIONS AND GRANTING
RESPONDENT'S MOTION TO EXTEND DEADLINE TO
FILE OPPOSITION TO COMPLAINANT'S MOTION FOR RECONSIDERATION**

The Hawai'i Labor Relations Board (Board) issued Order No. 3755, Setting Deadlines for Dispositive Motions. Complainant NARCIS D. SALERA (Salera) submitted a Motion to Extend Deadline for Dispositive Motions which, among other things, requested that the deadlines set forth in Order No. 3755 and the Motion Hearing set in the same Order be extended for fourteen days as the parties are working on a potential settlement to the dispute. Respondent WESLEY T. YOKOYAMA, Director, Department of Environmental Services, City and County of Honolulu (Yokoyama) submitted a statement of no opposition to Salera's Motion.

The Board further issued Order No. 3754, Dismissing Counts VI and VII of the First Amended Complaint for Lack of Jurisdiction, and Salera submitted a Motion for Reconsideration, asking the Board to reconsider Order No. 3754. Yokoyama submitted a Motion to Extend Deadline to File Opposition to Complainant's Motion for Reconsideration, and Salera submitted a statement of no opposition to Yokoyama's Motion.

After review of the motions and the record, the Board hereby GRANTS both Motions for good cause. Accordingly, the Board sets the relevant deadlines as follows:

Any and all dispositive motions must be filed on or by **June 29, 2021 by 4:30 p.m.**

Any and all responses to dispositive motions must be filed on or by **July 7, 2021 by 4:30 p.m.**

Any opposition to Salera's Motion for Reconsideration must be filed on or by **June 30, 2021 by 4:30 p.m.**

The Motion Hearing scheduled for June 29, 2021 is hereby rescheduled as set below in the Notice of Motion Hearing.
