**ORDER DENYING COMPLAINANT'S EX-PARTE
MOTION TO SHORTEN TIME FOR FILING A RESPONSE TO
SALERA'S MOTION FOR SECOND EXTENSION OF
DEADLINE FOR DISPOSITIVE MOTIONS AND
THE DATE OF HEARING ON DISPOSITIVE MOTIONS
AND FOR OTHER APPROPRIATE RELIEF AGAINST RESPONDENTS**

On June 18, 2021, Complainant NARCIS D. SALERA (Salera) filed a Motion for Second Extension of the deadline to submit dispositive motions and to move the date of the motion hearing on dispositive motions and for other relief (Motion for Extension).

On June 21, 2021, Salera filed an Ex-Parte Motion, asking the Hawai'i Labor Relations Board (Board) to shorten the time for Respondent WESLEY T. YOKOYAMA, Director, Department of Environmental Services, City and County of Honolulu (Yokoyama) to respond to the Motion for Extension.

Through the Declaration of Ernest H. Nomura, Yokoyama opposed the Ex-Parte Motion.

Hawai'i Administrative Rules (HAR) § 12-42-8(g)(C)(iii) provides:

Answering affidavits, if any...shall be filed with the board within five days after service of the motion papers, unless the board directs otherwise.

After review of the Ex-Parte Motion and the Declaration of Ernest H. Nomura, the Board hereby DENIES the Ex-Parte Motion.
