ORDER SETTING DEADLINE FOR
COMPLAINANTS TO FILE SECOND AMENDED COMPLAINT

In their Pretrial Statement, Respondent DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT, State of Hawai'i (DHRD) asserted that the Amended Complaint was flawed because the department-wide searching and bumping processes that Complainants allege violated the collective bargaining agreement § 12 were conducted by the Department of Public Safety, State of Hawai'i (PSD) not DHRD.

Accordingly, at the July 8, 2021 Pretrial Conference, the Hawaii Labor Relations Board (Board) raised the issue of whether the Department of Public Safety, State of Hawai'i (PSD) should be added as a named respondent in this case. Complainants' attorney agreed to file a Motion to File a Second Amended Complaint to add PSD as a named respondent by Monday, July 19, 2021.

Therefore, the Board orders that Complainants file a Motion to File a Second Amended Complaint by **Monday, July 19, 2021 at 4:30 p.m.** All previous hearing dates and deadlines set forth in Order No.3722, as amended, are cancelled.
