ORDER GRANTING COMPLAINANT'S MOTION TO WITHDRAW PROHIBITED  
PRACTICE COMPLAINT AND DISMISSING AND CLOSING THE CASE

On June 9, 2022, Complainant JOSEPH H. CAMPOS II, Ph.D. (Complainant) filed with the Hawai'i Labor Relations Board (Board) a motion to dismiss pursuant to a private settlement agreement (Motion to Dismiss).

Complainant filed an Errata to the Motion to Dismiss requesting that the prohibited practice complaint (Complaint) be dismissed with prejudice and that the Proposed Findings, Conclusions, and Order (Proposed Order) be withdrawn or dismissed.

On June 14, 2022, Respondent UNIVERSITY OF HAWAI'I AT MĀNOA (Respondent or UH) filed a statement of no position to the Motion to Dismiss (UH Position). In its Position, UH did not oppose the Motion to Dismiss and took no position regarding Complainant's request that the Proposed Order be withdrawn or dismissed.

Under Hawai'i Administrative Rules § 12-42-44, any prohibited practice complaint may be withdrawn at any time prior to the issuance of a final order upon motion and with consent of

the Board. Therefore, because no final order has been issued, the Board construes the Motion to Dismiss as a motion to withdraw the Complaint under this provision.

For these reasons and based on the full record in this case, the Board consents to the withdrawal of the Complaint in this case and orders that this case is dismissed and closed.
