On July 12, 2022, the Hawaii'i Labor Relations Board (Board) issued a notice of the filing of a petition of declaratory ruling (Notice of DR Petition) in this case. Among other things, the Notice of Petition noticed a hearing to rule on any petitions of intervention that may be filed and a status conference to be held on August 10, 2022.

On July 28, 2022, Petitioner HUNTER C. HENKEL (Petitioner) filed a motion to continue the hearing and status conference because of a conflict with his attorney's previously scheduled civil trial (Motion to Continue).

The Board finds that good cause exists for a continuance of this hearing and status conference and GRANTS the Motion to Continue.
