## ORDER DISMISSING IMPASSE CASE

On August 24, 2022, the Hawai'i Labor Relations Board (Board) issued a Notice of Intent to Dismiss in this case. The Board received no written notification within the specified time period from any party to the proceeding setting forth the reasons why this case should not be dismissed. Therefore, the Board dismisses this case for mootness under Hawai'i Administrative Rules (HAR) § 12-42-76(b).

Under HAR § 12-42-128, the Chief Negotiator for the Employer Group Ryker Wada or his designee is further ordered to submit both an electronic copy and a hard copy of the final collective bargaining agreement reached in this case, including any applicable memoranda of understanding or memoranda of agreement within thirty-days of execution and issuance.
