SCHEDULE OF COSTS AND CHARGES

• Professional Fees

My professional fee for arbitrations and mediation services is <u>\$275.00 per hour</u>. My professional fee is calculated by multiplying my hourly rate by the total amount of time spent on the case from commencement until termination. General excise tax is billed at the rate of 4.712%. Invoices are submitted every 30 days.

• <u>Costs</u>

1. Postage and Photocopying

Photocopying costs are billed at the rate of \$.20 per page. Postage costs are billed at their actual cost.

2. Travel Expenses

I bill for direct travel expenses including airfare (economy class), baggage fees, change fees, taxi, car rental and lodging (if necessary) and parking at their actual cost. I do not charge for travel time or meals.

3. Miscellaneous Costs

Other miscellaneous costs incurred such as conference room rental are billed at actual cost.
