FEES AND CHARGES

Per Diem

My *per diem* fee is \$2,100. A day, for purposes of calculating this fee, is seven hours or less. If a hearing extends beyond seven hours, an additional \$300 per hour will be charged. Travel, study and writing are billed in half-day increments.

Cancellation

If a scheduled hearing day is cancelled more than 21 days in advance, there will be no fee. If a scheduled hearing day is cancelled 21 days or less in advance, a cancellation fee of \$2,100 will be charged for each cancelled day.

Expenses

Expenses for travel, lodging and meals are billed at cost. Receipts will be provided if requested in advance.
