

**Associate Justice Simeon Acoba, Jr., (ret.)** (B.A. '66 University of Hawai'i, Manoa; J.D. '69, Northwestern University School of Law) was appointed to the Supreme Court of Hawai'i in May 2000. He served until his mandatory retirement age in 2014. Prior to his appointment to the Supreme Court, he was an associate judge on the Intermediate Court of Appeals from 1994 to 2000, a circuit court judge from 1980 to 1994, and a per diem district court judge from 1979 to 1980. Acoba has served as a lecturer at the William S. Richardson School of Law at the University of Hawai'i at Manoa during 2013-2019. He was a member of the University of Hawai'i Board of Regents, having been appointed to a regent position from October 2014 to June 30, 2017, and from July 1, 2017 to June 30, 2022. He also served as a director on the board of the University Clinical Education and Research Associates, a separate non-profit corporation that was affiliated with the University medical school.

Acoba started his career as a law clerk to Chief Justice William Richardson of the Hawai'i Supreme Court, and was a special assistant to UH President Harlan Cleveland. He then served as a deputy attorney general, and later was engaged in the private practice of law. During his practice, he also served as a special deputy attorney general for the Hawai'i division of occupational safety and health; the campaign spending commission; and the Hawai'i public utilities division; as a Hawai'i State House of Representatives staff attorney for the Majority; and as an adjunct professor at the Richardson School of Law.

He was the founding chair of the Hawai'i Access to Justice Commission, a 22-member board with representatives from the three branches of government and other legally related entities, from 2008 to 2010 and was again appointed Chair of the Commission by the Chief Justice from January 2016 to Jan 2020. Appointed by the President of the Bar, Acoba is also co-chair of the Hawai'i State Bar's Judicial Administration Committee that is composed of approximately twenty judges and attorneys. In 2023 he was elected by the Bar for a term of six years as one of its two representatives on the Hawai'i Judicial Selection Commission. He also serves as a director on the boards of the Hawai'i Justice Foundation and of the Mediation Center of the Pacific and chairs a committee on the Hawai'i chapter of the American Judicature Society.

Acoba is the 2013 recipient of the national Dwight D. Opperman Award for Judicial Excellence from the American Judicature Society, the Distinguished Service Award from the Honolulu Chapter of the Japanese American Citizens League, the Lifetime Achievement Award from the Filipino Community Center, the Golden Gavel Award, and the President's Award from the Hawai'i State Bar

Association, the Fellow of the Pacific Award from Hawai'i Pacific University, and a Lifetime Achievement Award from the UH Founders Alumni Association.

He is affiliated with Dispute Prevention and Resolution, Inc. located in Honolulu, Hawai'i and has served as a mediator, arbitrator, appellate practice judge, and a court discovery master. He is also on the panel of arbitrators with the Hawai'i Labor Relations Board.
