ARBITRATOR PROFESSIONAL FEE UPDATE - Hourly Rate: \$250 per hour (10.7.25)

The professional updated fee of \$250 is the new hourly rate for Arbitration and Mediation services by Dr. Kahu Kaleo Patterson. This fee of \$250 per hour covers all time spent on a case, including hearings, pre-and post-hearing research, and writing the final award.

These costs are generally split between the union and the employer, though specific rules vary by arbitration provider and jurisdiction. This fee may be adjusted in accordance with specific conditions, requests, or requirements considered and agreed upon by two parties.

In addition to professional fees above the arbitrator shall be reimbursed for reasonable expenses, such as travel, hotel accommodations, and meals.

Cancellation policy: Arbitration agreement to include a cancellation policy that details the fees to be paid if a hearing is canceled or postponed.
