ORDER TO SHOW CAUSE

On January 1, 2023, Claimant FABIUS MENDOZA ("Claimant/Decedent") died.

Following a hearing on August 2, 2023, the Director of Labor and Industrial Relations issued a Decision Supplemental to Award Dated 12/6/2018, entered on August 16, 2023. The Director's decision, in relevant part, determined that Claimant/Decedent did not have any dependents pursuant to Section 386-42, Hawaii Revised Statutes.

On August 30, 2023, Fabian Mendoza filed an appeal of the Director's decision. Mr. Mendoza represented that he is the twin brother of Claimant/Decedent.

The file is devoid of any record confirming that Mr. Fabian Mendoza is the court-appointed personal representative or special administrator of Claimant/Decedent's estate.

On September 5, 2023, Employer HBM ACQUISITIONS, LLC filed an appeal of the Director's decision.

Mr. Fabian Mendoza; Claimant/Decedent FABIUS MENDOZA; Employer HBM ACQUISITIONS, LLC; and the SPECIAL COMPENSATION FUND shall respond to this Order to Show Cause why Mr. Fabian Mendoza's appeal filed on August 30, 2023 should not be dismissed for failure to establish his standing to file an appeal of the Director's August 16, 2023 Decision Supplemental to Award Dated 12/6/2018 and/or his authority to file an appeal on behalf of Claimant/Decedent FABIUS MENDOZA of the Director's August 16, 2023 Decision Supplemental to Award Dated 12/6/2018.

This Order to Show Cause does not affect Employer's appeal of the Director's August 16, 2023 decision, filed on September 5, 2023.

You are hereby notified that a hearing on the Order to Show Cause is set for **Thursday**, **November 30**, **2023 at 10:30 a.m.**, **Hawaii Standard Time** or as soon thereafter as the parties may be heard by the Board.
