NOTICE OF INTENTION TO DISMISS

On May 15, 2025, the Labor and Industrial Relations Appeals Board issued an Order Holding Case in Abeyance and Notice of Intention to Dismiss. In relevant part, the Board recognized that Claimant LIONEL N. LIMA, JR. ("Claimant") appealed decisions by the Director of Labor and Industrial Relations, which appeals are designated as above-referenced Case No. AB 2018-256(S)(T). The Board acknowledged that, in **Case No. 2017-326(T)(S)**, Barbara Ann Delizo-Lima ("Ms. Lima") informed the Board that Claimant passed away on October 10, 2023. The Board also discussed that on January 8, 2025, the Board requested that Ms. Delizo-Lima provide written

confirmation that identified her as the court-appointed personal representative or special administrator of Claimant's Estate. In closing, the Board issued its May 15, 2025 order, holding the above-referenced appeal in abeyance until **October 1, 2025**, pending the Board's receipt of a written appearance by a court-appointed personal representative or special administrator of Claimant's Estate. The order stated that Claimant's above-referenced appeal may be dismissed after **October 1, 2025** unless an appearance is made by either a court-appointed personal representative of Claimant's Estate or a special administrator of Claimant's Estate. The order further stated that extensions by the Board may be granted upon good cause shown or at the discretion of the Board. A courtesy copy of the Board's May 15, 2025 order was provided to Ms. Delizo-Lima.

On September 29, 2025, Board Chair Damien A. Elefante wrote to Ms. Delizo-Lima. In relevant part, the Board Chair acknowledged the Board's receipt of Letters of Administration (filed by the First Circuit Court of the State of Hawaii on July 25, 2025) from Ms. Delizo-Lima in **Case No. 2017-326(T)(S)**. The Board Chair specifically inquired of Ms. Delizo-Lima whether or not she would like the Board to acknowledge her July 25, 2025 Letters of Administration for purposes of the above-referenced appeal.

To date, the Board has not received a response from Ms. Delizo-Lima regarding the Board Chair's September 29, 2025 correspondence.

To date, the Board has not received a request to extend the deadlines as set forth in the Board's May 15, 2025 order.

To date, a court-appointed personal representative or special administrator of Claimant's Estate has not appeared in the above-referenced appeal.

NOTICE IS HEREBY GIVEN that an Order of Dismissal will issue herein unless good cause to the contrary is shown in writing within ten (10) days after filing of this notice.
