II. Old Business

A. State Fire Marshal appointment.

Presentation of findings and recommendations of the Permitted Interaction Group that was formed at the SFC 3rd Quarter Meeting on January 27, 2025. The board anticipates going into executive session to discuss this item based on section 92-5(a)(2), Hawaii Revised Statutes, which allows a board to hold an executive session "[t]o consider the hire, evaluation, dismissal, or discipline of an officer or employee or of charges brought against the officer or employee, where consideration of matters affecting privacy will be involved; provided that if the individual concerned requests an open meeting, an open meeting shall be held[.]"

- B. SFC may discuss and adopt the general positions and policy direction on fire-related legislative topics, subject matters and legislative measures, including the bills in II.C., the State Fire Marshall, fire safety, the state fire and building codes, fireworks, firefighters, the county fire departments, and other fire-related bills.
- C. Potential discussion of the following legislative bills discussed at the <u>SFC 3rd Quarter</u> Meeting on January 27, 2025.
 - 1. House Bill (HB) 1, amends responsibilities of the State Building Code Council.
 - HB 55, converts certain fireworks-related offenses from misdemeanors to class C felonies.
 - 3. HB 83, increases penalties for certain firework violations and establishes higher penalties for any subsequent violation.
 - 4. HB 113, requires certain owners and occupants of properties located in hazardous fire areas to maintain effective firebreaks within thirty feet of the property and to practice other fire prevention activities.
 - 5. HB 187, increases fines that may be assessed against certain fireworks-related violation.
 - 6. HB 200, imposes a statewide limitation on consumer fireworks, except by permit for use at cultural events.
 - 7. HB 201, supplements salary of the State Fire Marshal.
 - 8. HB 361, requires the Hawaii Emergency Management Agency to: (1) Adopt the

National Incident Management System as the standard for all incident management and emergency response operations; (2) Complete an after-action review for all significant emergency incidents or exercises; (3) Develop and manage position task books; (4) require the use of standardized Incident Command System forms; (5) Maintain accreditation through the Emergency Management Accreditation Program; and (6) Define specific roles and responsibilities for all Incident Command System and emergency operations center positions. Expands training and education qualifications and responsibilities for the Administrator of Emergency Management and county-level administrators or directors of emergency management. Amends the contents of the state comprehensive emergency management plan.

- 9. HB 367, allows for building permit exemptions for certain kinds of activities.
- 10. HB 415, amends the sunset date of Act 83, Session Laws of Hawaii 2012, to repeal section 46-19.8, Hawaii Revised Statutes, on June 29, 2025.
- 11. HB 596, clarifies the types of events that constitute disasters and emergencies for the purposes of emergency management.
- 12. HB 608, Establishes the shipping container inspection program and shipping container inspection program special fund. Amends the definitions of "aerial devices" and "fireworks" within state fireworks law.
- 13. HB 627, appropriates funds to the Department of Education for positions to implement and maintain school safety measures.
- 14. HB 745, beginning 1/1/2028, makes the most recent Hawaii state building codes adopted by the state building code council supersede all existing county building codes and thereafter allows counties to remove requirements of the state building codes or add requirements to the state building codes only with prior council approval. Repeals the counties' authority to adopt, amend, and update the Hawaii state building codes for their respective county building codes.
- 15. HB 806, appropriates funds for the Honolulu Police Department and Department of Law Enforcement to conduct sting operations on Oahu to enforce fireworks ordinances or laws. Authorizes a court to order the forfeiture of one-half of any pension of an Employees' Retirement System member, former member, or retirant upon conviction of the individual for a felony related to certain uses of prohibited fireworks.
- 16. HB 1064, amends the laws concerning the Office of the State Fire Marshal to best effectuate the recommendations of the "Phase 3" Forward-Looking Report by Fire Safety Research Institute on the August 2023 Maui wildfires.
- 17. HB 1280, requires the State Fire Marshal to convene an electric vehicle fires working group to examine the impact of electric vehicle fires in residential, commercial, and business properties that have confined parking structures.
- 18. HB 1419, defines stages of wildfire suppression efforts.
- 19. HB 1483, establishes an adjudication system and procedures to process fireworks infractions. Amends multiple definitions and penalties for fireworks offenses,

including heightened penalties if another person suffers substantial bodily injury, serious bodily injury, or death as a result of the fireworks offenses. Establishes various criminal offenses and penalties related to fireworks or articles pyrotechnics. Appropriates funds.

- 20. Senate Bill (SB) 11, requires the Department of Land and Natural Resources to create and annually update a wildfire hazard map.
- 21. SB 17, establishes the Wildfire Mitigation Working Group. Requires a report to the Legislature.
- 22. SB 43, requires the State Building Code Council to assess the financial impact of the adoption of a code or standard on single-family and multi-family home.
- 23. SB 130, requires government entities to seek reimbursement for all or a portion of search or rescue expenses for persons who require rescue after leaving a hiking trail to enter an area closed to the public or hiking on a trail closed to the public, and there is a sign giving notice of the closure.
- 24. SB 223, requires certain owners and occupants of properties located in hazardous fire areas to maintain effective firebreaks within thirty feet of the property and to practice other fire prevention activities.
- 25. SB 302, amends the definition of "cultural". Prohibits the use of consumer fireworks except for cultural use by permit. Repeals the wording of section 132D-3(1), HRS, that generally allows the use of consumer fireworks without a permit on New Year's Eve, New Year's Day, and the Fourth of July.
- 26. SB 303, amends the sunset date of Act 83, Session Laws of Hawaii 2012, to repeal section 46-19.8, Hawaii Revised Statutes, on June 29, 2025.
- 27. SB 309, requires periodic inspections of certain walls and appurtenances of buildings five or more stories in height.
- 28. SB 376, establishes a refundable income tax credit for taxpayers who construct or install improvements to their residence that increase the residence's fire safety rating as calculated by the taxpayer's homeowner's insurance policy.
- 29. SB 436, provides that no person shall serve as State Fire Marshal for more than 3 terms.
- 30. SB 476, increases fines that may be assessed against certain fireworks-related violations.
- 31. SB 508, establishes the hike safe card program and search and rescue special fund to be administered by the Department of Land and Natural Resources. Requires government entities to seek reimbursement for all or a portion of search or rescue expenses when the person or entity knowingly enters state, county, or private property, knowingly enters a hiking trail that is closed to the public, or violates applicable laws, provided that the closure is posted by sign, barricade, or other device that gives reasonable notice of the closure. Exempts persons who possess a hike safe card from search and rescue cost reimbursement, under certain conditions.

- Requires counties and the State Fire Council to adopt ordinances or rules as necessary to pursue reimbursements.
- 32. SB 512, requires the State Fire Marshal to establish a Statewide Firefighting Helicopter Program. Appropriates funds for the State Fire Marshal to obtain helicopters, facilities equipment, drones, and supplies; hire and train staff; and do other things necessary to ensure that the Program is ready to begin providing aerial firefighting services on 7/1/2026.
- 33. SB 514, establishes the Hawaii Wildfire Relief Fund and Hawaii Wildfire Relief Fund Corporation within the Department of Commerce and Consumer Affairs.
- 34. SB 554, requires claims of post-traumatic stress disorder suffered by first responders to be compensable under workers' compensation under certain conditions if the post-traumatic stress disorder resulted from the first responder acting within the course and scope of the first responder's employment.
- 35. SB 555, creates a presumption for workers' compensation purposes that diseases of the heart in firefighters and law enforcement officers were proximately caused by and resulted from the nature of the person's employment if certain conditions are met. Exempts injuries caused by disease of the heart from certain time limitations applicable to workers' compensation claims. Establishes a process for regular physical examinations of firefighters and law enforcement officers to reduce heart disease risks.
- 36. SB 611, prohibits the sale, importation, personal use, and commercial use of all fireworks, except consumer fireworks. Removes permitting requirements for consumer fireworks.
- 37. SB 632, requires the State Building Code Council to develop and adopt a green building standards code.
- 38. SB 649, requires the Department of Transportation to inspect personal aircraft that enter the State and land at state airports for the purpose of preventing the unauthorized transportation of fireworks and article pyrotechnic into the State. Requires the Department to coordinate with an appropriate law enforcement agency or county fire department to dispose of prohibited fireworks and articles pyrotechnic.
- 39. SB 871, designates mandatory minimum periods of imprisonment for individuals with previous arson convictions. Requires additional penalties for arson crimes that endanger vulnerable areas. Requires restitution for victims of arson who experienced property damage.
- 40. SB 999, repeals all permissible uses of consumer fireworks and makes conforming amendments to the Fireworks Control Law. Establishes civil penalties for the use and sale of consumer fireworks, including nuisance abatement proceedings and forfeiture of assets used in the commission of the illegal use or sale of consumer fireworks. Establishes the Firework Forfeiture Special Fund to deposit asset forfeiture proceeds and to provide for community safety education programs.
- 41. SB 1102, establishes that the Chief of the State Aircraft Rescue Fire Fighting Unit of the Airports Division of the Department of Transportation shall serve not more than

three terms of four years each.

- 42. SB 1110, companion bill to HB 361.
- 43. SB 1177, establishes within the Office of the State Fire Marshal the Office of the State Search and Rescue Coordinator. Provides for the authority and duties of the State Search and Rescue Coordinator. Establishes the search and rescue special fund. Appropriates moneys.
- 44. SB 1201, establishes the Wildfire Recovery Fund. Allows securitization for electric utilities.
- D. SFC may discuss and decide whether, and to whom, it will delegate or redelegate the authority to track legislative measures, draft testimony, and discuss and address legislative matters.
