# II. Approval of Minutes

A. June 14, 2017

A motion to approve the June 14, 2017 minutes was made by Elaine Young. Debbie Miyao seconded the motion. The motion to approve the minutes was approved unanimously.

### **III.** New Business

A. Brief overview of meetings with Workforce Connect held on July 18-19, 2017... Scott Murakami, Chair, Data Management & Technology Committee

Thomas Kusnirik and Lou Ansaldi representing the Information Technology Support Center (ITSC) delivered a presentation on Workforce Connect. Workforce Connect is a software application that helps connect WIOA partners as a "common front door" for workforce agencies' programs and systems, including unemployment insurance, employment services and workforce development.

Allicyn Tasaka mentioned that the Reemployment System Integration Dislocated Worker Grant that the Workforce Development Council received is being currently reviewed by the U.S. Department of Labor (USDOL) to see if rebudgeting of funds within the grant can be done. However, Allicyn strongly recommended that the cost allocation for surveys within the grant should be kept.

From the Workforce Connect meetings, Thomas and Lou were able to provide the partners with a cost estimate for the system integration. The cost estimate was reviewed by the core partners.

B. Discussion by WIOA Core Partners towards agreement on a common unified statewide system

Discussion by the core partners regarding a common unified statewide system ensued. Elaine Young presented concerns for the Workforce Development Division as to how the various systems would be connected and after the integration is completed, the maintenance cost to maintain the system. For Adult Education, Lester Tanji offered concerns with the self-service component with Workforce Connect. Linda Uesato representing Unemployment Insurance (UI) expressed security concerns for their UI system with the single sign-on module added.

A motion was made for the core partners to accept a single sign-on process. A motion to accept the single sign-on process was made by Elaine Young. Lester Tanji seconded the motion. The motion was approved unanimously.

# C. Next steps and timeline

Scott Murakami recommended that the core partners meet as a team to discuss and formulate the common application.

Sheryl Nojima inquired to see if there will be a project manager involved with the project since there is a significant scope of work.
