E.R.K. v. State of Hawaii Dept. of Education

April 2013

Hawaii DOE changes the diploma issued by the Community School for Adults (CSA) to a Hawaii Adult Community School diploma.

The diploma is no longer a high school diploma. It is a high school diploma equivalency.



August 28, 2013

UNITED STATES COURT OF APPEALS FOR THE NINTH CIRCUIT E.R.K. v. State of Hawaii Dept. of Education page 19.

None of the DOE's arguments sway us from our conclusion that the Community Schools for Adults offer "free public education" to students who do not require IDEA services. The DOE offers, at taxpayer expense, the opportunity for nondisabled 20- and 21-year-olds to complete their secondary educations and earn high school diplomas. Providing IDEA services to disabled children of those ages would therefore be consistent with "State law or practice ... respecting the provision of public education," so the state must do so. 20 U.S.C. § 1412(a)(1)(B)(i).

Summary

The ninth circuit court of appeals found that a high school diploma from the Hawaii DOE or the Community Schools for Adults is the same therefore IDEA services need to be provided to eligible students 20 and 21 years old as required by federal law.



Post-Secondary Federal Financial Aid

The following are the equivalent of a high school diploma as described in CFR Title 34 Part 600.

- I. A General Education Development Certificate (GED);
- 2. A State certificate received by a student after the student has passed a State-authorized examination that the State recognizes as the equivalent of a high school diploma; This includes evidence of a passing score on tests recognized by the state and similar to the GED, such as the High School Equivalency Test or HiSET and the Test Assessing Secondary Completion or TASC.
- 3. An academic transcript of a student who has successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree; or
- 4. For a person who is seeking enrollment in an educational program that leads to at least an associate degree or its equivalent and who has not completed high school but who excelled academically in high school, documentation that the student excelled academically in high school and has met the formalized, written policies of the institution for admitting such students.
