I. <u>Call to Order</u>.....*Committee Chair Shannon Okinaka* The meeting was called to order at 9:00 a.m. by Committee Chair Shannon Okinaka.

II. Overview of Budget for Period July 1, 2018 to December 31, 2018

Looking at the WDC Comprehensive Budget and Expenses as of December 31, 2018, there were \$544,500 in administrative expenses, leaving a little over \$1 million remaining in the budget. There is \$957,375 remaining in the rapid response budget, of which about \$300,000 will lapse as of June 2019. There is \$936,841 remaining in the WIOA Reemployment/Integration Grant and will end September 30, 2019. There has been about \$8,000 in recorded expenses for the Kauai rain and flooding with around \$15,000 in expenses pending, leaving a \$492,006 balance. The Hawaii volcano eruption disaster grant also has pending expenses with \$13,175 in recorded expenses and a balance of a little over \$1.1 million. There is a little over \$7,000 in recorded expenses for the general fund leaving \$443,440 remaining.

As of June 30, youth, adult and dislocated workers returned \$284,000 so WDC will use those funds to pay HireNet costs for all counties. Using the \$320,000 unused funds in rapid response, WDC will provide mobile equipment to each of the counties to conduct rapid response activities off-site and update the rapid response section on the WDC website.
