**Re: WARN Notice**

Dear WARN Act Coordinator:

A certain Cerner Corporation (“Cerner”) business partnership with Adventist Health will end in early November 2019. As a result, Cerner employees at Adventist Health Castle, 640 Ulukahiki St., Kailua, HI 96734, will be terminated on December 1, 2019. Cerner is providing this notice to comply with any obligations it may have under the Hawaii and federal WARN Acts. It is concurrently providing WARN notice related to other locations as well.

These terminations are expected to be permanent. There are no bumping rights and the employees are not represented by a union. There are approximately 37 Cerner employees, and all will be terminated. Affected employees may have an opportunity to accept comparable employment with Adventist Health or another organization on or about November 4, 2019.



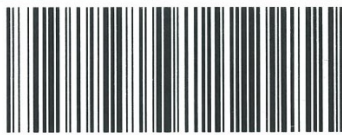
